Another judge has been assigned in Canyon County to assist with the case load. Judge Murray will schedule mediations and make recommendations to Judge Tucker. Hopefully this will speed of the process. Marinda also asked the panel to go through the proper chain of command for questions or concerns. It may take up to 90 days for E-Cabinet to be updated so panel members should continue checking for updates.

At 11:00 am Chairman Hal Iverson made the motion to go into Executive Session. The motion was seconded by Angie Martinez.


At 12:00 pm Chairman Hal Iverson made the motion to go out of Executive Session. Co-Chair seconded the motion. Meeting adjourned.
