1:25	Crisis Center Update	Annie Burton, Pathways	trained for this work Update from Pathways -Transition -Needs from SWDH or Advisory Committee -Questions for Pathways -A main priority for Pathways is to get staffing to an appropriate level, especially at night -They are still trying to recruit clinicians (this has been difficult in the Caldwell area) and have increased their onboard bonus; Annie is going to speak with NNU and other local colleges to engage their alumni network -There were 28 intakes in the first week and as of today there have been 39 client intakes -Referrals have mostly come from Canyon County Sheriff's Office and self-referrals, but DHW has also referred some folks -Success story for Week 1: Annie developed a partnership with Moonlight recovery to waive the monthly fee for folks who need their services. A client was successfully referred to Moonlight and is grateful to be there; Moonlight is coming to WIDCCC next week to do a training on get folks successfully referred -WIDCCC is having a vendor table to promote the program this Saturday -Annie is working on relationships with faith-based organizations, such like the Catholic church; St. Vincent de Paul will drop off food every Wednesday to support the nourishment of crisis center clients -Annie has formed a relationship with Olive Garden and Starbuck's for food, as well -WIDCCC provides clients with a personal hygiene bag, food, and water upon discharge -There are a lot more partnerships meetings: immediate priority for partnerships is law enforcement (Vito will be a point of contact for Annie to support this effort) -There have been some minor incidents where some clients have been unwilling to sign consent to treat or part with their cell phone; Annie described the difference between	Cas is going to schedule a walk-through of WIDCCC for the Advisory Committee Cas is going work with the building manager to address some of the facilities concerns
