### **CALL THE MEETING TO ORDER**

### REQUEST FOR ADDITIONAL AGENDA ITEMS; APPROVAL OF AGENDA

Panel members reviewed the agenda.

## APPROVAL OF MEETING MINUTES - 6/1/2023

Panel members reviewed the meeting minutes from the meeting held June 1, 2023.

Chairman Hal Iverson shared a list of questions from the OPE and asked the panel to review his responses and make recommendations no later than July 18, 2023.

The State will post a survey in the near future and try to have it wrapped up by the end of 2023.

### **OVERVIEW OF STATE CRP MEETING FROM JULY 12,2023**

Chairman Hal Iverson recapped the State CRP meeting from July 12,2023. Hal received a list of government services for foster parents that he will share with the panel.

Funding going to the Health Districts for CRP has been reduced. Chairman Hal Iverson will talk with SWDH Finance Manager to see if there will be funds available for travel to the National CRP Conference.



Each District is facing a variety of challenges when reviewing cases. District 4 feels there is not enough transparency from IDHW and feels they are not getting a lot of support. Other districts expressed the same issue. District 7 stated they are getting resistance from H&W. They would like to do more in-depth reviews but are having a hard time. Substance abuse is the common theme. There are districts struggling to get a full panel. Southwest District Health now has a full panel, and more cases are able to be reviewed. It was suggested that panel members from different districts join a meeting with other panels, in hopes to increase efficiency. Chairman Hal Iverson brought a list of CRP members for each district.

## ROUNDTABLE OF MEMBERS REGARDING NEW CRP CHAIRMAN:

Chairman Hal Iverson is stepping down from the position of CRP Chairman at the end of August. He asked if anyone was willing to step into his position. He agreed to stay on the panel for a few months to help get the new chairman trained. It was agreed that there would also be a co-chair to support the chairman. There will be a final decision at the next meeting in August.
