CALL THE MEETING TO ORDER

Co-Chair Karee Curry called the meeting to order at 9:05

REQUEST FOR ADDITIONAL AGENDA ITEMS; APPROVAL OF AGENDA – 10/5/2023

Panel members reviewed the agenda.

MOTION: John Baldazo made a motion to approve agenda for October 5, 2023 with no additional items to add. Lori Rainboth seconded the motion. All in favor; the motion passed unanimously.

APPROVAL OF MEETING MINUTES – 9/7/2023

Panel members reviewed the meeting minutes from the meeting held September 7, 2023

MOTION: Angie Martinez made a motion to approve the September 7, 2023 Citizen's Review Panel meeting minutes as presented. John Baldazo seconded the motion. All in favor; motion passed.

CASE REVIEW PROCESS: Co-Chair Karee Curry asked the panel if they had any issues, concerns or comments regarding the current process for assigning cases.
