			The group thanked Madison for her willingness to participate and Bethany for her	
			contribution to the committee	
1:15	SWDH	Cas A.	Follow-up on questions from last month's meeting	
	Updates	SWDH	Cas reviewed the email she sent to the committee on Monday, May 13 th which addressed	
			the questions from May's meeting including questions about funding negotiated with	
			Pathways for FY24, return on investment, Magellan funding, and sustainability.	
			WIYSC Update	
			There have been 80 admissions to the youth crisis center since opening January 29 th .	
			Youth have come for a variety of crises and presenting concerns. Most have come from	
			Canyon County with some from Ada, Payette, and Owyhee Counties. They have been	
			referred from a variety of sources, referred to a variety of services, and the center has	
			demonstrated diversions from harm to self/others, hospital visits, and law enforcement	
			interaction.	
			MCO/Magellan Update	
			The minimum standards for crisis centers was officially published by Medicaid. Now that	
			these standards have been published Magellan will be getting the contract to SWDH	

			shortly.	
			Commissioner Aberasturi asked what we should expect from FY26, particularly if SWDH	
			has to step down from overseeing the center. The consensus is that because we don't	
			have an idea of what Magellan's plan for supporting the centers at that time we will have	
			to play it by ear.	
			WIDCCC Budget Update	
			Based on Troy's presentation to the Board of Health in May, the adult crisis center is doing	
			fine financially.	
			We have options like donations and the SAMHSA grant to tap into once Troy can provide	
			final numbers for the budget period. This may not occur until later in the Summer.	
			Commissioner Aberasturi asked if Luma is working and Nikki indicated that Luma is still not	
			reliable, but Troy has better information on the back end than Cas does as a budget	
			manager on her end.

	Presentation		May's census was lower than March and April's but continues to be higher than months	
			previous to Spring.	
			WIDCCC sees more males than females and more mental health associated needs than	
			SUD needs.	
			Referrals have been mostly made to intensive outpatient care and other community-based	
			care.	
			Seeing very minimal clients who are veterans despite the high number of veterans living in	
			our community. Abigail is working with her team to address how WIDCCC captures this	
			information to ensure. She attended a SIM training for Veterans last week last week and	
			made connections with will support veterans who visit the center.	
			WIDCCC is also trying to better understand how they capture presenting concerns (MH,	
			SUD, co-occurring, none).	
			They are also trying to understand how to be more effective at referrals. Some referrals to	
			Terry Reilly for example have fallen through the cracks. Abigail believes that staff at	
			WIDCCC will be able to make appointments with clients, so that less referrals fall through.	
			-Success stories	
			Abigail shared that a client who visited WIDCCC often finally agreed to get into recovery.	
			This shows that clients listen and the work we do with them is meaningful, even if staff	
			don't recognize it right away. The vehicle was also used over 10 times in the last month for	
			client transportation! This has been helpful when public transportation is not accessible.	
			Abigail also shared that they are getting better at utilizing each person's role in the center	
			and shared three quotes from clients who have found their time at the center beneficial.	

			-Challenges	
			There has been a small influx of more aggressive clients, which has required WIDCCC to	
			involve law enforcement. Staff are getting connected to more de-escalation training and	
			work directly with the clinician and management to navigate these situations.	
			There has also been staffing changes, which has been an opportunity for more training,	
			particularly as we move into the Magellan transition, which comes with a transition in the	
			EHR and system from Magellan.	
			-Discussion	
			Nikki asked about presenting concerns (how many were co-occurring). Nikki also asked	
			about why the referrals seem lower than normal. Abigail indicated that it's often due to	
			folks who are coming in that don't necessarily need a referrals (just stabilization) or repeat	
			visitors who have referrals already.	
			Commissioner Aberasturi asked about partnerships with healthcare and behavioral health	
			providers. Abigail spoke to the new partnerships she's made from the SIM training and Cas	
			mentioned that a new person just started for the SAMHSA grant who will be responsible	
			for continued partnership development as it relates to increasing crisis center visits and	
			referrals.	
			Cas asked why we think there was a dip in May census. Abigail indicated that when it	
			starts getting warmer census generally dips due to being able to better manage the	
			outside temperature and a potential increase in overall mood during better weather.
