### AUDIT UPDATE

Troy Cunningham, SWDH Financial Manager, provided an update on the recently concluded financial audit. He reported that financial statements are on hold until the issues with Luma reporting specifically around cash balancing that are prohibiting getting trial balance to match with cash balance are resolved. The auditors are working on the issue.

### CANYON COUNTY PRE-PROSECUTING DIVERSION PROGRAM OVERVIEW

Vito Kelso, SWDH Program Manager, provided an overview of the Canyon County Pre-Prosecution Diversion Program. Canyon County received \$1.8 million in state grant funds to be awarded over a 3-year period. The work done through the program follows the collective impact model and allows for early intervention, case management, and peer support.

This program meets multiple essential public health functions of communicating effectively to inform and educate people about health, and to strengthen community partnerships.
