1:05	SWDH Updates	Cas, SWDH Wendy, SWDH	<p>SWDH Standing Updates</p> <ul style="list-style-type: none"> ● Western Idaho Youth Support Center Update ● WIDCCC Funding and Budgets <p>Cas was absent due to illness. She provided a brief update on her items to the committee via email.</p> <ul style="list-style-type: none"> ● Rural Outreach Update <p>Wendy reported on her meeting with the Saint Alphonsus Urgent Care team which included 38 doctors, Nurse Practitioners, and physician assistants from Canyon and Payette Counties.</p> <p>Out of those numbers 8 had never heard of the crisis system of care and 9 had just passing information about it.</p> <p>There were a number of doctors on the call that were interested in learning more about the crisis center and having a tour.</p> <p>I dropped off information to the organizer of the event and gave him Abigail's email.</p> <p>During WIDCCC meeting Abigail said no one had reached out to her yet, which may be due to the holidays.</p> <p>Wendy will reach back to them in the New Year and see if they need any other resources and ask if they are still interested in a tour.</p> <p>Wendy reported on her trip to Cambridge with Kaydin to present to the tri-valley co-op. She explained that there had been two high profile deaths by suicide and one attempt by youth that had the community wanting support.</p>	

			<p>Tri-valley Co-op is made up of Adams, Washington and Valley County.</p> <p>We found out Ignite Idaho is providing less support in Adams and Washington Counties, making information on the crisis centers and crisis system more necessary.</p> <p>Wendy also gave an update on Canyon County Juvenile probation and parole outreach. For most it was a refresher but there were new employees and the youth support center had not yet opened the last time we talked to them.</p> <p>They are interested in touring WIYSC but Abigail had not heard from them.</p> <p>The crisis system of care training and outreach is still planned for Grandview/Bruneau school district on January 16th.</p>	
1:25	Crisis Center Update	Abigail, Clarvida	<p>Monthly WIDCCC Presentation & Discussion</p> <p>Census picked back up a bit in November from October but was still lower than September – there were 122 full episodes and 6 non-episodes.</p> <p>In November there was a closer split between male and female clients, but the percentage of unhoused and mental health services provided remains common.</p> <p>In November we saw referrals from other crisis providers and a small number from MH/BH providers with most coming from other referrals sources such as self-referrals.</p> <p>Diversions in November were predominantly from hospital admissions and law enforcement, with a small number prevented from harm to self.</p> <p>Clients were referred to community-based resources, outpatient, and inpatient/hospital, with one referral to residential.</p> <p>Updates include the transition of the new program supervisor who came to WIDCCC from the Boise adult crisis center – she has a lot of strengths that will benefit WIDCCC.</p> <p>Due to the removal of certain programs by Magellan, WIDCCC has seen a lot of applicants for open positions and they are preparing their team for possible increase in census.</p>
